

What is the EMS Star of Life?

The EMS Star of Life event is designed to honor the accomplishments of EMS personnel from all regions of Tennessee who provide exemplary life-saving care to **adult and pediatric** patients. The goal of the award is to recognize exceptional front-line care, with a focus on agencies and providers who are the initial care responders. The ceremony will include a presentation of the actual adult or pediatric patient scenarios and reunite the EMS caregivers with the individuals they treated. Recipients will be chosen from each of the eight EMS regions in the state. This is the premier event that will kick off EMS week within the state to recognize and honor our excellent prehospital providers.

If you know a rescue or medical team that merits consideration as the regional recipient of the EMS Star of Life Award, please complete the nomination packet that follows and return it to the TN EMSC office by **February 9, 2015**. ***Please note that although hospital care is included in the save, hospital care providers are not awarded the Star of Life Award, only EMS agencies.**

The **EMS Star of Life Awards** are designed to:

- ❑ **HONOR** exceptional EMS personnel from each of Tennessee's eight EMS Regions.
- ❑ **RECOGNIZE** Tennessee's emergency medical services systems and organizations.
- ❑ **REUNITE** EMS providers with the person treated and highlight the actual patient scenario.
- ❑ **GENERATE** positive media stories regarding prehospital care and the **EMS Star of Life Award**.
- ❑ **MAGNIFY** the profile of National EMS Week in the State of Tennessee.

The TN EMSC EMS Star of Life Awards Committee reviews nominations and selects winners from each region based on the EMS provider's service to his/her community and commitment to saving the lives of his/her patients. In order to ensure that all qualified EMS providers are considered, we are asking for nominations for recipients of this prestigious **EMS Star of Life Award**. Please note the nomination qualifications:

- ❑ The patient encounter must have occurred during the calendar year of 2014.
- ❑ The patient can be of any age – adult or pediatric.
- ❑ The patient must be neurologically intact.
- ❑ Standards of care (protocols) are followed.
- ❑ The patient EMS run sheets and aeromedical documentation will be submitted and reviewed for completeness.
- ❑ All requested information must be submitted in order for the award to be presented.

If you know an EMS provider(s) who merits consideration as the regional recipient of the **EMS Star of Life Award**, please complete the forms enclosed and forward the appropriate information to the TN EMSC office. **Please note: It is important to have the patient sign the release form before you submit this information in order to release you and TN EMSC from any liability for reviewing these records.** Also, it is our desire to have the patient reunited with the EMS providers at the ceremony, so please discuss this with the patient and encourage them to attend with their family. Once all nominations are reviewed, the EMS Star of Life Awards Committee will notify you if your EMS personnel have been chosen.

The deadline for nomination submissions is February 9, 2015.

On Thursday, January 30, 2014 with our shift coming to an end, the 911 emergency phone toned out for a person potentially not breathing. The crew had been busy all day and was currently spread throughout the plant working on sprinkler systems due to the freezing temperatures we were experiencing. Paramedic Dustin Housewright and EMT/Lieutenant Jeff Lane jumped in the ambulance and responded to the emergency. While enroute an update was asked for with Dispatcher/EMT-IV John Wilber responding that the caller states the person was not responding and is blue in color. We arrived on scene at B-147 Wellness Center to find Carvis Harlow lying in the floor with bystander Lee White performing chest compression. At this time, paramedic Housewright said across the radio "patient in full cardiac arrest." Paramedic Housewright assessed the patient for a pulse, found he was pulseless then took over chest compressions. In the meantime, EMT Jeff Lane was preparing to ventilate the patient. Within seconds Paramedic Tracy Hicks arrived with the cardiac monitor and EMT-IV Terry Gilliam took over chest compression to allow the Paramedic's to prepare advanced life support interventions.



Paramedic Housewright placed the patient on the cardiac monitor, the monitor showed a rhythm of ventricular fibrillation and paramedic Housewright readied the heart monitor to give a defibrillation shock to the patient. This first defibrillation was delivered within 5 minutes of receiving the call. The rhythm converted to a sinus bradycardia rhythm. EMT Lane yelled he has a pulse. The decision was made to quickly move the patient onto a long spine board and get him to the ambulance. This equipment was retrieved by Lieutenant/EMT Eric Kent, EMT-IV Robert Jarvis and EMT-IV Phil Gunter. Kent and Housewright carried the patient down 2 sections of stairs and then placed him in the ambulance. The decision was made to stay on scene for an extra amount of time to get interventions started. EMT's Gunter and Jarvis assisted Paramedic's Housewright and Hicks in getting these interventions accomplished. These initial interventions included establishing 2 IV's, administering cardiac arrhythmia medications, placing an advanced airway and defibrillating the patient another 4 times. After each defibrillation the patient regained a rhythm with a pulse present. With Lieutenant Lane driving, emergency transport was initiated to Holston Valley Medical Center Emergency Department. During transport the patient became somewhat agitated and pulled his airway out. After this the patient was administered a sedative medication to calm him down so that Paramedic Housewright and Hicks could appropriately treat and monitor the patient. Upon arrival at Holston Valley ER Eastman's emergency crew were met by an array of nurses, respiratory therapists and ER physician Dr. Luna. The patient was then transferred to the ER staff's care with a pulse and breathing naturally with assisted ventilations. Eastman's crew of EMT's and Paramedic's relied on their excellent skills, training and utilization of excellent teamwork to provide Mr. Harlow with a chance to live another day.

Please explain why you think the *EMS Star of Life Award* should be given to the nominees:

When minutes count, having the right emergency responders makes all the difference. On January 30th, 2014 Eastman's Crew #1 EMS team was able to arrive within two minutes of the call and literally save the patient's life. The dedication and training of this ALS service is exemplified in the crew's ability to deal with life and death situations and make a difference. Emergency responders in Plant Protection Department's Emergency Services section at Eastman Chemical Company participates in extensive monthly and annual training to prepare for situations just like this. This team is one of four crews that represent Eastman's Emergency



services. And this is one of **Nine saves** that have occurred since 2009 on the Eastman site (March 2009, June 2009, January 2011, November 2011, February 2012, August 2012, June 2013, January 2014, and Dec 2014), each involving one of the four Eastman crews and all involving cardiac arrest patients. This high success rate is due in part to the ability to respond to any location on site, generally within three minutes or less.

Eastman's Management is committed to providing a full time, state licensed ALS service at its Kingsport site. It is a large site with more than 9000 employees and contractors working on a 900 acre campus with over 600 buildings. Eastman plant site also committed to providing CPR training at no cost to all interested employees. Since 2012 Eastman trained over 1045 employees in CPR. With this dedicated emergency service comes the ability to respond to all types of medical emergencies on site. Parker Smith, vice president and general manager of World Wide Manufacturing Support for Eastman has said: "If I ever have a heart attack, I would rather it be at Eastman than anywhere else". Our EMS folks do a fantastic job; they have both a great response time and capability. "They know what to do."
