Written Narrative for Star of Life nominee Robert Tatanish

Fighting fire is a dangerous profession. Robert Tatanish can tell you that firsthand. When a brush fire got out of hand on his land on February 27, 2014, Putnam County Fire Department personnel responded to find Robert already out fighting the fire by himself. Shortly afterwards, the situation got really bad. Robert suddenly collapsed on scene, witnessed by the firemen. The chain of events that followed this are the reason that Robert is alive today.

The firefighters immediately recognized what was happening, called 911, and began CPR. First Responders from Putnam County Rescue Squad and both First Responders and an ambulance from Putnam County EMS responded. All responders worked together, continuing CPR and shocking Mr. Tatanish multiple times. His pulse returned, and they transported him to the hospital, continuing care along the way, and notifying the hospital that he was having a STEMI after performing a 12 lead ECG. The cardiology team was waiting on Robert, and successfully treated him. He was discharged from the hospital in stable condition a few days later.

Why I think the EMS Star of Life Award should be given to the nominees:

This is a great example of early recognition of the emergency, early notification of 911, and early CPR. The firefighters were there to fight a fire, but responded quickly to do CPR. It should also be noted that neither of the firefighters who performed CPR were medically trained. Multiple agencies worked together to help Mr. Tatanish, which resulted in the best possible outcome. Following ROSC, a 12 lead was performed, which indicated a STEMI. They notified the E.D. of this, which prepared the cath lab team for Robert. All aspects of the system flowed together.
