Nashville, TN---In 2008, ambulance services in Tennessee responded to over one million 911 calls. The first annual EMS Star of Life Awards Dinner & Ceremony honored the dedication of those who provide day-to-day lifesaving services on the medical "front line" in Tennessee. The ceremony presented actual patient scenarios and reunited the EMS caregivers with the individuals they treated from the eight EMS regions across the state.

Northeast Tennessee was represented by the exemplary care given by Hawkins County EMS and WellmontOne Flight Service in rescuing Jamie Lawson of Bulls Gap, TN. Mr. Lawson was critically injured on August 15, 2008 after being ejected from his tractor. He had a loss of consciousness at the scene for an undetermined amount of time and then walked to a home nearby for help. Hawkins County EMS responded and subsequently called WellmontOne Flight Service. Mr. Lawson suffered a closed head injury and multiple fractures. He spent five days in intensive care, but fully recovered after four months with no long term affects.

Unfortunately, Mr. Lawson can not join us this evening but we spoke with by telephone and he expressed his sincere "appreciation and thankfulness that the rescue crew knew what to do because he doesn't remember anything."

Special recognition and remembrance was given of Earl Morphew, the flight paramedic on duty with WellmontOne that day. Mr. Morphew was a strong advocate for early launch, which turned out to make a difference in Mr. Lawson's outcome by expediting early trauma care. In early January, Mr. Morphew achieved certified flight paramedic status.

He was one of only a thousand or so paramedics to have achieved this level of certification worldwide. The education and experience required to receive this certification insured his patients received exceptional care, which was always his goal. Mr. Morphew tragically died in an auto accident on his way to work on January 28, 2009. He was struck by a drunk driver
